

Here are four obituaries of valued members. All were extremely proud First Fleeters, all participated in the life of the Fellowship as well as making their mark among fellow Australians.

Elizabeth Adele King #2403 FF William Tunks

Elizabeth, or Betty as we knew her, was born on the 19th November 1921. She joined the Fellowship during the 1980s and was a volunteer with the Membership Committee and a Foundation Member of the Tunks Descendants Association, which awarded her a Life Membership. Betty's business and secretarial skills were of the utmost help during the surge of FFF membership around the Bicentennial year. Failing health necessitated a move from her family home in Earlwood where she resided after a marriage break-up, to eventually settle in the Hawkesbury Retirement village in Richmond. She managed to keep up her happy and gregarious sprit surrounded by her family and friends. As we shared Great Grandparents I always looked forward to her reminiscences of the Tunks Family. She passed away on the 18 October 2007 and we convey our deepest sympathy to her immediate family, sister-in-law Doreen Tunks, and her beloved niece Vicki-Lynne.

Benarr [Bunny] Philip Sloan #6215 FF Anthony Rope/Elizabeth Pulley

Bunny was born on 24 October 1921 and died on 31 May 2007. A service to celebrate his life was held on 28 October at Boronia House, Mosman, attended by friends, FFF members, cousins from the Rope/Pulley family, members of Legacy and former business associates. My one regret is that I did not get to know Bunny better. He would invariably appear at our Australia Day Luncheon accompanied by his lovely wife, Elizabeth. They both spent part of the year in the United States but it was patently obvious that his thoughts would always stray back to his homeland, Australia. At the service we were regaled with a selection of his favourite tunes, mainly of the 4os, 50s and 60s. We heard a splendid rendition of Mackellar's My Country, and sang a stirring version of Waltzing Matilda! The finale was Wish Me Luck as You Wave Me Goodbye! It was a happy occasion of thanksgiving for the life and work of this proud First Fleeter and above all a proud Australian. During his lifetime Bunny was a free thinker but always respected the views of his fellow men and women. Some of us would pray that his soul would rest in peace and that he would rise in glory. Bunny, no doubt, would debate this point but God does move in a mysterious way, His wonders to perform. The Fellowship offers to Elizabeth and Bunny's family deepest sympathy on their loss.

Dorothy Mooney FF Matthew Everingham

I have not the details of Dorothy's birth and death but was saddened to learn of her passing in the last Newsletter. Over the past two decades Dorothy has donated to our Library a number of volumes of her literary efforts including details of her life and a host of her down-to-earth poems. She was a proud descendant of Matthew Everingham and the love of her fellow human beings shone through the pages of her writings. I had never met her, but always looked forward to her written thoughts. She was one of those few souls who sincerely believed and acted according to the principles of the Good Book. Naida Jackson #877 FF William Tunks

Naida's descent came through her mother, Laura Liebau nee White. She was born on the 9 December 1917 and diied on the 8 September 2007. She joined the Fellowships iin 1970 and over the years took an active part of the Executive. She was also a Foundation Member of the Tunks Descendants Association, a member of the first Committee and an Honorary Life Member. I first had the distinct privilege of meeting Naida, a distant cousin, when I joined the Fellowship in 1981. That year the Membership Committee consisted of some four Tunks Descendants out of the seven members. Joyce Cowell, [Convenor and Archivist], Len Chalmers, Naida and her sister Hazel Liebau. She became the Convenor of the committee in the 1990s and was involved in the processing of over four thousand members from 1981 to 1990. Naida had a great gift of getting along with people, she had a dedicated commitment to the Fellowship, a wonderful sense of humour, was a help and mentor to new chums and, indeed, it was my great fortune to work closely with her during my Presidency. A number of we older members have happy memories of her. Theret was that day in July 1988 at the opening of First Fleet House and Naida was out on the footpath with a broom to ensure that the Governor and his Lady would have a tidy entrance to our new headquarters. On another occasion, soon after, a thief entered the premises and took off with Naida's purse. She chased him to Cathedral Street, cornered him in a nearby garage, grabbed her purse from him, and returned alittle breathless, but triumphant, to the office. Not bad for a 71-year-old! After that incident she ensured that a security grill was installed at the entrance doorway. I was delighted when she was nominated and received Life Membership of the Fellowship. With her passing another chapter in the history of our Fellowship has closed. We give thanks for every remembrance of her and offer our deepest sympathy to her family, Penelope, Paul and her grandchildren. Regrettably I was unable to be present at her funeral but John Daniell AM, a former President of the Tunks Descendants Association, wrote"

The celebration of the life of Naida Jackson was held in a lovely, small sandstone church, St John's at Mona Vale on Tuesday the 11 September last. Three members of Naida's family gave Eulogies to remind us what a devoted Mother and Grandmother Naida was. And how she was always looking after family members when they needed her love and care. A Souther Highlands Calvacade of Fashion





Australia's First Chief Constable

Who knows the first Chief Constable of Australia?

Upon arrival, Susannah and the other women of the Fleet were kept on board the Charlotte_in-Sydney Cove until nine days after the men had been disembarked. Upon disembarkation, Susannah and Henry were confronted with most of their goods having "disappeared" during the journey of the First Fleet. Henry Kable was determined to care for his family and stubbornly sought assistance from First Fleet legal minds. This led to his successful suit five months later in Australia's first civil action against the captain of the ship Alexander who was ordered to pay the Kables 15 pounds in compensation. The significance of this case was that as a convict in England, Kable would never have been allowed to bring a case to court (felons were 'dead' in law). It was a radical departure in common law for Phillip and Judge Advocate David Collins to

allow Henry to bring the case to court in the Colony and says something about Governor Phillip's liberal attitude towards convicts. Phillip wrote that he intended to build a free society here. This case created a precedent in law: It was used down the ages by convicts to win court cases and so accrue political freedoms that would otherwise have been denied them. Professor Neal in his book *The Rule of Law in a Penal Colony* has a lot to say about Kable's role in building today's free society. "[They] conscripted the rule of law to transform New South Wales from a penal society to a free society" pp.195-6. Remarkably in 1981 Judge Staples successfully used the precedent set by Kable to allow prisoners at Bathurst Gaol (including the infamous Darcy Dugan) to bring a case to court.

This action supports the view that Arthur Phillip governed the convict colony in a sensible and humane way, despite conditions which included poor quality food, largely infertile land and a lack of experienced farm labour which led to near-starvation.

Earlier Henry and Susannah's marriage ceremony was conducted on 10 February, very soon after the Fleet's disembarkation. Reverend Richard Johnson married them before a large crowd including Governor Phillip who personally wished them well. At this time the settlement consisted of nothing more than filthy hovels and tents that gave no privacy to their occupants.

By the end of the first year of settlement the Kables' second child Diana was born. The settlement had progressed somewhat to include stone houses for Governor Phillip and Major Ross of the Marines, secure store houses and raked vegetable gardens. Phillip requested a detachment of marines to stand watch at night over these gardens and attendant poultry -- this however was deemed unworthy of the marines by Major Ross and led to one of many arguments between the two men.

To overcome the lack of protection at night twelve convicts including Kable were appointed to patrol the settlement, divided into four groups of three to patrol their sectors which included the convicts' huts and public farm area, the brick kilns and surrounding gardens, the western side of Sydney Cove and the huts and gardens around the hospital area. On only his third nght of watch Kable made an arrest of a convict found "unlawfully about".

This lawful determination of Kable brought him to further notice of Governor Phillip who appointed him as an overseer of one of the convict gangs responsible for clearing land for the new town of Sydney. Kable enjoyed his new-found responsibility and was renowned for his forthright attitude and 'forceful' method of ensuring other convicts complied with his instructions. He continued on his watch duties and was able to make a harsh life a little easier for his growing family.

But a commercial centre was also growing -- where were to be found the wharves and dockyards, the bonded stores, granary and provision stores, the market place, the small general hospital and the town gaol.
